The Sixth Street Gallery Fiber Arts Festival is a juried show celebrating the full spectrum of fiber arts. We welcome all two- or three-dimensional fiber-based art and craft pieces, from the traditional to the contemporary.

Submissions

Artists are invited to submit up to three pieces for jurying. There is a jury fee of \$20. The jury fee is \$10 for youth artists 14 years or younger. For MOSAIC Arts Alliance members the jury fee is \$15. Checks or money orders should be made payable to Sixth Street

Gallery; cash is also accepted. Submission forms, accompanying materials, and payment should be mailed to or dropped off at:

Please include an SASE for acceptance notification. Additionally, artists may include an SASE for return of submission materials. No materials will be returned without a SASE.

Instructions

Artists may submit slides, photos, or digitals. Slides must be labeled with artist's name, title, and an arrow or "TOP" indicating the top of the slide. Photos must be labeled with artist's name and title. Digital files must be labeled with first initial, underscore, last name, underscore, and title (example: a_artist_untitled.jpg). Files may be jpg or tif and must be on a CDR.

Please do not submit original work for jurying or any pieces that have hung in previous shows at Sixth Street Gallery.

If you wish to enter electronically, email your entry form information and digital images to shows.ssg@gmail.com. You may pay through Paypal by sending a payment to the same email address. Please note that the jury fee is \$25, \$15 for youth, and \$20 for MOSAIC Arts Alliance members if paid by Paypal - incomplete entries will not be considered.

All entries are due by 5:00pm on June 20, 2010.

Accepted Work

Artists accepted into the show will be notified the week of June 28, 2010. Accepted work must be mailed or delivered in person by

August 1. **Any hanging wall art must have proper hanging wire on its back; no sawtooth hangers.** A \$10 fee will be charged for each piece that is not properly wired for hanging. Sixth Street Gallery reserves the right to reject any work that differs greatly from the juried sample or that is not ready for display.

Artists are encouraged, but not required, to offer accepted work for sale. Sixth Street Gallery will take a 35% commission on all sold pieces.

All accepted pieces must remain at Sixth Street Gallery during the dates of the show, August 4 – 29, 2010. Unsold pieces must be picked up from Sixth Street Gallery by September 12. Artists wishing to have work shipped back to them must pay return shipping costs and send artwork in sturdy, reusable packaging. Artwork not picked up by September 12 will be subject to a storage fee of \$3 per day. Any pieces not claimed within 60 days after September 12 will become property of Sixth Street Gallery.

All reasonable care and precaution will be taken in the handling, storing, and installing of artwork. Sixth Street Gallery will not be responsible for loss or damage of any entry.
